The qualification to be a **Full Member** as detailed under Rule 5 of the constitution is as follows:

- Owns one or more commercially rated properties within the Waiuku economic development rated area; or

- Occupies or is the tenant of one or more premises (with a floor space of not less than 10sqm) of a commercially rated property within the Waiuku economic development rated area and who operates a business from those premises for not less than 50 business days a year
- AND, provide current details of their name, occupation, business and contact information to the secretary of the association Sharlene Druyven for the purpose of this AGM

Election of members to the Executive Committee

The procedure for nominations as detailed in Rule 14 of the constitution is as follows:

Nomination of candidates for election

- Shall be made in writing, signed by two **Members** of the Association, and accompanied by the written consent of the candidate (which may be endorsed on the form of the nomination); and
- Shall be delivered to the Waiuku Town Centre Manager for the purposes of this AGM) not less than seven days before the date fixed for the AGM (5pm on Tuesday 19th October 2021)
